Sub: Inviting applications for appointment to the posts of Expert Members in the National Green Tribunal (NGT).

The Government of India enacted the National Green Tribunal (NGT) Act, 2010 (19 of 2010) for effective and expeditious disposal of cases relating to environmental protection and conservation of forests and other natural resources including enforcement of any legal right relating to environment and giving relief and compensation for damages to persons and property and for matters connected therewith or incidental thereto. As per Section 3 of the NGT Act, 2010 the Central Government established the National Green Tribunal.

2. The Ministry of Environment, Forest and Climate Change, Government of India invites applications for filling up the 6 vacant posts of Expert Members in the NGT as per the provisions of the NGT Act, 2010, from eligible Indian Citizens. Mere eligibility will not entitle any candidate for being short-listed or selected.

3. The educational qualifications, eligibility and terms and conditions of the appointment of a candidate will be governed by the provisions of the NGT Act, 2010 (19 of 2010) and Rules made thereunder, including the NGT (Manner of Appointment of Judicial and Expert Members, Salaries, Allowances and other Terms and Conditions of Service of Chairperson and Other Members and Procedure for Inquiry) Rules, 2010, as amended from time to time. The NGT Act, 2010 and Rules made thereunder, including their amendments, are available on the Ministry's website: www.moef.gov.in.

4. The Tribunal has five places of sitting, namely, New Delhi, Bhopal, Chennai, Kolkata and Pune. An Expert Member, upon selection, may be posted at any of these places.

5. The Central Government reserves the right to withdraw advertised posts at any time without assigning any reason and also reserves the right to increase or decrease the number of vacancies as well as fill or not to fill the posts and its decision in this regard shall be final.

Eligible and interested persons may submit their applications in the prescribed format alongwith all supporting documents (self attested) to **Director, Policy and Law Division, Ministry of Environment, Forest & Climate Change, Level-III, Jal Wing, Indira Paryavaran Bhawan, Aliganj, Jor Bagh, New Delhi - 110003 on or before 29th November, 2019 (05:00 PM).**
7. Applications which are incomplete or not in the prescribed format or not accompanied by the supporting documents, as mentioned above, shall not be entertained and would be liable to be summarily rejected by the Competent Authority.
8. No TA/DA will be admissible to the candidates to be called for interview/ interaction. The candidates are required to make their own arrangements.
