

TAMIL NADU POLLUTION CONTROL BOARD AMBIENT AIR QUALITY AND NOISE LEVEL REPORT IN CHENNAI CITY DURING DEEPAVALI – 2025

The Honorable Supreme Court of India in Writ Petition (C) No. 728/2015 dated 23.10.2018 has directed Central Pollution Control Board (CPCB) and respective Pollution Control Boards (SPCBs/PCCs) of the States and Union Territories to carry out short-term monitoring of Ambient Air Quality and Noise level Surveyin their Cities for 15 days (commencing from 7 days before Deepavali, during Deepavali 20.10.2025 and ending 7 days after Deepavali).

Based on the above directions of the Hon'ble Supreme Court and guidelines of the Central Pollution Control Board (CPCB), Government of Tamil Nadu and Tamil Nadu Pollution Control Board (TNPCB) issued directions to bursting of crackers from 06.00 a.m. to 07.00 a.m. and 07.00 p.m. to 08.00 p.m. on 20th October 2025.

Further, considering the significance and the harmful effect caused due to the bursting of crackers to the Environment and to health of the people and thereon to protect the environment, every year the TNPCB is taking various follow-up actions in this regard. Accordingly, action is being taken to create awareness among the public through schools, colleges, Eco clubs and National Green Corps (NGC) with the help of School Education, Higher Education Departments, Social media and Frequently Modulation (FM radio) and issued directions to Director General of Police, all District Collectors, Director of Environment and Commissioners of all Municipal Corporations in Tamil Nadu.

Tamil Nadu Pollution Control Board has conducted manual monitoring survey for Ambient Air Quality monitoring at 39 stations and Noise monitoring Survey at 34 stations covering major Districts of Tamil Nadu State including Greater Chennai Corporation from 13.10.2025 to 27.10.2025 viz., Chennai-7, Coimbatore-2, Cuddalore-2, Madurai-2, Tirunelveli-2, Kanyakumari-2, Tanjore-2, Trichy-2, Vellore-2,

Salem-2, Chengalpattu-2, Dindigul-2, Krishnagiri-2, Thoothukudi-2, Tiruppur-2, Nagapatinam-2 and Kancheepuram-2.

On Deepavali day (20.10.2025), Ambient Air Quality Survey was conducted on 20.10.2025, 06.00 a.m to 21.10.2025, 06.00 a.m and based on the analysis report, the Air Quality Index (AQI) was arrived, in which the lowest level was observed in Besant Nagar 190 AQI (Moderate) and Highest level was observed in Valasarawakkam 332 AQI (Very Poor) in Greater Chennai Corporation. Further, the results of Ambient Air Quality of other districts were enclosed in Table -1.

On Deepavali day (20.10.2025) from 06.00p.m to 12.00p.m the Noise monitoring Survey was conducted in Greater Chennai Corporation and the lowest Noise level value was observed at Besant Nagar 62.8 dB (A) and the Highest Noise level value was observed at Tiruvottiyur 88.4 dB(A). Further, the results of Noise Level Value of other districts were enclosed in Table -2.

Based on the survey during Deepavali day (20.10.2025), the values of AQI and Noise were exceeding the National Ambient Air Quality standards.


